SECTION VI - HEALTH HAZARD DATA

Routes of Exposure:

Health Hazards (Acute and Chronic):

Inhalation: May cause dry throat, coughing, headache, vomiting, chest pain, irritability, depression, loss of weight and pneumonitis

Ingestion: Relatively non-toxic, slow absorption.

Skin: May cause redness and itching.

Eye: May cause redness, itching, swelling and watering.

Emergency and First Aid Procedures:

Inhalation: Remove victim to fresh air, keep warm and quiet, and give oxygen if breathing is difficult, seek medical attention.

Eye: Flush eyes with lukewarm water, lifting upper and lower eyelids for at least 15 minutes and seek medical attention.

Steps to be taken in case material is released or spilled:

Wear appropriate respiratory and protective equipment specified in section VIII. Isolate spill area, provide ventilation and extinguish sources of ignition, Vacuum up spill using a high efficiency particulate absolute (HEPA) air filter and place in a closed container for proper disposal. Take care not to raise dust.

Waste disposal method:

Dispose of in accordance with state, local, and federal regulations.

Store in cool, dry area and in tightly sealed container. Wash thoroughly after handling.
