*Eye:* Flush eyes with lukewarm water, lifting upper and lower eyelids for at least 15 minutes and seek medical attention

SECTION VII - PRECAUTIONS FOR SAFE HANDLING AND USE

*Steps to be taken in case material is released or spilled:*

Wear appropriate respiratory and protective equipment specified in section VIII. Isolate spill area, provide ventilation and extinguish sources of ignition. Vacuum up spill using a high efficiency particulate absolute (HEPA) air filter and place in a closed container for proper disposal. Take care not to raise dust.

*Waste disposal method:*

Dispose of in accordance with state, local, and federal regulations.

Store in cool, dry area and in tightly sealed container. Wash thoroughly after handling.
